# Incentivising freeport success

Forth Green Freeport is an environment where businesses can grow and thrive.

Where activity is environmentally sustainable and where innovation flourishes.

Forth Green Freeport has access to a suite of incentives, which positions it as a lead international trade hub, a location of choice for inward investment, a leader in clean technologies, and an accelerator of job creation.

Our Tax Sites at Grangemouth, Mid-Forth and Rosyth provide reliefs to reduce the cost and risk of developing new facilities. Customs benefits like duty deferral and simplified procedures offer new trade and export opportunities.

Seed funding of £25 million is in place to encourage new infrastructure and to unlock development plots, backed by a commitment from the Scottish Government and local authorities to have a focused Forth Green Freeport approach to planning. Help is also available from Government agencies to support and promote potential investors, along with the mechanics and regulatory support to encourage innovation.

The impact of Forth Green Freeport is national but local communities benefit too, with new jobs and economic regeneration and growth aided by increased non-domestic rates for local authorities.

With a range of financial incentives, co-operation between public and private sectors and re-investment into the local economy, Forth Green Freeport is playing its part in the reindustrialisation of Scotland and securing a just transition.

#### Tax incentives

Forth Green Freeport comprises three Tax Sites covering the ports of Burntisland, Grangemouth, Leith, and Rosyth. Businesses investing in these locations can access a suite of tax incentives that will both significantly offset the costs of their initial investment in Forth Green Freeport and reduce their operating costs.

- Enhanced Capital Allowances tax allowances worth 100% of the cost of plant or machinery purchased for use in a Tax Site (available until 30 September 2034).
- Enhanced Structures and Buildings Allowance tax allowances worth 10% of the cost of constructing or renovating non-residential buildings and structures on a Tax Site (available until 30 September 2034).
- Employer National Insurance contributions relief exemption from making secondary Class 1 National Insurance contributions for new employees working primarily on the Tax Site earning up to £25,000 per year (available for 36 months per employee).
- · Land and Buildings Transaction Tax relief exemption from paying tax on the purchase/lease of non-residential land and buildings within a Tax Site (available until 30 September 2034).
- Non-Domestic Rates Relief exemption from paying tax on the occupancy of non-residential buildings (available until 30 September 2034).

# **Driving investment** in Green Freeport zones

Spanning over 500 hectares across Fife, Falkirk and Edinburgh, our Tax Sites have been strategically selected to encourage growth. Through reduction in the financial challenges and risk of investing in new developments, our Tax Sites will reassure you that you have made the right decision to invest in Forth Green Freeport.

#### Grangemouth

Home to Scotland's largest container port and principal freight hub, Grangemouth handles goods representing 30% of Scotland's Gross Domestic Product, Under Forth Green Freeport development plans. freight movements will be increased through the creation of new manufacturing and advanced logistics facilities.

The site also contains a major chemicals cluster. As part of Forth Green Freeport. this infrastructure will be transformed to focus on alternative fuels and carbon capture, utilisation, and storage. Grangemouth's infrastructure alongside its strategic location for hydrogen production and transmission positions it as a prime location for Net Zero manufacturing.

#### Rosyth

Rosyth is Scotland's bestconnected port. It hosts **Babcock International Group** Plc, an international defence company with one of the most technologically advanced manufacturing facilities in the UK. Rosyth is also home to the Arrol Gibb Innovation Campus, a vibrant ecosystem fostering innovation and growth by supporting industry to develop and scale their ideas, collaborating with researchers on pioneering projects and developing future skills today.

Queensferry One is a major new industrial and logistics development at the heart of Rosyth's growing advanced manufacturing and renewable energy cluster.

The Forth Green Freeport vision for Rosyth will see the promotion of new freight capacity. increased offshore renewable manufacturing and green power generating capacity.

#### Mid-Forth

**Encompassing the twinned** locations of Leith & Burntisland, Mid-Forth is vital to supporting Scotland's burgeoning floating offshore wind capacity. The Forth **Estuary is an optimal location** for deploying fixed and floating offshore wind turbines, thanks to its existing infrastructure. land, and deep water.

Forth Green Freeport's focus is on supporting Leith to become the leading hub for renewable energy and sustainable industries in Scotland. This is complemented by the high capacity integration and commissioning potential at Burntisland.

Leith also has a longstanding reputation as a location for the creative industries, bringing benefits to local businesses and Scotland.



# **Investment Principles**

If you want to access the range of generous tax incentives Forth Green Freeport offers, you will be invited to go through the Forth Green Freeport governance process to demonstrate that you meet the Forth Green Freeport's **Investment Principles.** 

This is important to ensure that new developments support the Green Freeport objectives and ultimately facilitate additional economic activity. Forth Green Freeport will carefully consider each development proposal on a case-by-case basis. As part of the Investment Principles, you must show that your development:

- 1. supports one or more of the Green Freeport policy objectives
- 2. is aligned with the priority sectors of Forth **Green Freeport**
- 3. is additional in terms of providing new jobs, investment, and accelerated growth

You will also be asked to commit to the Forth Green Freeport:

- Fair Work Charter
- · Skills Fund Policy and
- · Net Zero Charter.

#### Becoming a Customs Site Operator (CSO)

If you are looking to become a CSO within Forth Green Freeport, you will need to comply with the Forth Green Freeport Customs Policy for us to endorse your application to HMRC.

The Customs Policy sets out our process and requirements including expectations around meeting policy objectives. commitment to our Fair Work Charter and reaching Net Zero by Scotland's 2045 target. HMRC will ultimately decide whether your site is suitable to become a customs site.
